



Weekly Current Affairs (April 26th – 2nd May, 2024)

1. The **Indian Historical Records Commission (IHRC)** is an apex advisory body on archival matters in India. Established in 1919, the IHRC serves as a national forum for creators, custodians, and users of records, advising the Government of India on the management of records and their use for historical research. The IHRC is headed by the Union Minister of Culture.
2. India takes a significant step in renewable energy with the inauguration of its **first multi-purpose green hydrogen pilot project at the 1,500 MW Nathpa Jhakri Hydro Power Station (NJHPS) in Himachal Pradesh's Jhakri**. Spearheaded by Satluj Jal Vidyut Nigam (SJVN), the project aims to produce green hydrogen through renewable energy sources.
3. **Narsingh Yadav** Elected Chairman of WFI Athletes Commission. The Wrestling Federation of India (WFI) has completed the process mandated by the United World Wrestling (UWW), the global governing body for the sport. As a condition for lifting the suspension of WFI, UWW had instructed the federation to establish an Athletes Commission to address the grievances of wrestlers.
4. Axis Bank's board has approved the re-appointment of **Amitabh Chaudhry as Managing Director & CEO** for another three years, effective January 2025, subject to RBI approval. Alongside Chaudhry, Independent Directors Meena Ganesh and Gopalaraman Padmanabhan have also been re-appointed for four years each.
5. The Appointments Committee of the Cabinet (ACC) has approved the re-appointment of **T. Rabi Sankar** as Deputy Governor of the Reserve Bank of India (RBI) for a one-year term, effective from May 3, 2024. Sankar, a seasoned central banker with a career spanning over three decades at the RBI, was initially appointed as Deputy Governor on May 3, 2021, for a three-year period.
6. SEBI has granted approval to **CRISIL ESG Ratings & Analytics as a Category 1 provider of ESG ratings**, marking a significant development in the realm of environmental, social, and governance (ESG) assessments in India. This accreditation

underscores the growing importance of independent ESG ratings in financial markets, particularly in guiding decision-making for issuers and investors towards sustainable practices.

7. In a strategic collaboration, **NABARD has joined forces with the RBI Innovation Hub** to revolutionize agricultural lending through digitalization. The partnership aims to streamline loan processing and enhance accessibility for farmers across India.
8. SBI Card has introduced three variants of its travel-centric credit card, **SBI Card MILES**, catering to diverse travel needs. The variants—SBI Card MILES ELITE, SBI Card MILES PRIME, and SBI Card MILES—are designed to offer curated benefits to travelers, from frequent flyers to enthusiasts.
9. **Phi-3-mini** marks a significant milestone in AI innovation, offering unparalleled performance and efficiency. Microsoft's latest **small language model (SLM)** has surpassed benchmarks, demonstrating superiority over models of similar and larger sizes. Leveraged by prominent entities like India's ITC, Phi-3-mini showcases Microsoft's commitment to delivering cutting-edge AI solutions.
10. India's pharmaceutical exports witnessed robust growth in the fiscal year **2023-24, reaching \$28 billion**, marking a 10% increase compared to the previous fiscal year. Despite a 3% dip in total exports, the

pharmaceutical sector demonstrated resilience and significant expansion.

11. **Air India** has entered into a codeshare partnership with **All Nippon Airways (ANA)**, Japan's largest airline. This agreement, effective from May 23, 2024, will allow passengers of both airlines to combine flights between India and Japan using a single ticket.
12. The **Indian Air Force (IAF)** has achieved a significant milestone by successfully testing a new version of an air-launched medium-range ballistic missile. The missile, codenamed **ROCKS or Crystal Maze 2**, was test-fired from a **Su-30 MKI fighter jet** in the Andaman and Nicobar Islands.
13. In a prestigious ceremony held at Mumbai's **Dinanath Mangeshkar Natyagrih**, actor Randeep Hooda was bestowed with the **Lata Deenanath Mangeshkar Award**. This honor recognizes his remarkable contributions to Indian cinema and his recent film "**Swatantrya Veer Savarkar**".



14. Every year, on **April 26th**, we observe the **International Chernobyl Disaster Remembrance Day**. This day is dedicated to remembering the victims of the Chernobyl nuclear disaster and raising awareness about this catastrophic event. On April 26, 1986, the Chernobyl Nuclear Power Plant in Ukraine (formerly part of the Soviet Union) exploded, releasing a massive radioactive cloud into the atmosphere. This disaster exposed approximately 8.4 million people to harmful nuclear radiation.
15. **World Intellectual Property Day is celebrated annually on April 26th by the World Intellectual Property Organization (WIPO)**. The official theme for World Intellectual Property Day 2024 is **'IP and the SDGs: Building Our Common Future with Innovation and Creativity'**. The theme highlights the importance of IP in achieving the Sustainable Development Goals (SDGs) and creating a better future for all.
16. The world lost **Sudhir Kakar**, a renowned writer, cultural critic, and the **"Father of Indian Psychology,"** who passed away at the age of 85. Kakar's life and work bridged the gap between Western and Eastern thought, leaving an indelible mark on the field of psychoanalysis in India.
17. **The Gem & Jewellery Export Promotion Council (GJEPC)** announces a significant milestone for India's Gem and Jewellery (GJ) industry as it receives Authorized Economic Operator (AEO) status from the Ministry of Finance. This status, previously denied, now facilitates smoother export-import processes, reduces cargo release times, and lowers bank guarantees by 50%, aiming to enhance ease of doing business.
18. In the recently released **2024 Special 301 Report by the U.S. Trade Representatives (USTR)**, India finds itself on the Priority Watch List for intellectual property (IP) protection and enforcement. This decision comes amidst ongoing concerns regarding India's handling of IP security issues.
19. In the latest advancement of China's space program, the **Shenzhou-18** mission saw the successful launch of a three-member crew aboard the **Shenzhou-18 spacecraft**. The mission's objective is to rendezvous with the Tiangong space station, marking another milestone in China's ambitious space exploration endeavors.

20. In a groundbreaking announcement, **Saudi Arabia's oil behemoth, Aramco, and the international football governing body, FIFA, have joined forces in a strategic global partnership.** The deal, spanning until 2027, designates Aramco as FIFA's Major Worldwide Partner exclusively in the energy sector, encompassing sponsorship rights for marquee events including the FIFA World Cup 2026 and the FIFA Women's World Cup 2027.
21. **Coromandel International Ltd. (CIL),** a leading provider of agri-solutions, has announced a significant leadership transition. **Arun Alagappan,** the former Executive Vice Chairman, has been appointed and re-designated as the Executive Chairman of the company.
22. The Reserve Bank of India (RBI) has instructed **Talkcharge Technologies** to halt the issuance and operation of its **Prepaid Payment Instruments (PPIs) or wallets.** This directive follows the RBI's observation of the firm issuing wallets without proper authorization. As a result, Talkcharge must refund the balances held in these wallets to customers by May 17, 2024.
23. **The National Institute of Public Finance and Policy (NIPFP) predicts India's GDP growth for the fiscal year 2024-25 to be 7.1%.** Utilizing high-frequency models, NIPFP underscores the government's fiscal consolidation efforts, emphasizing tax buoyancy and compression of revenue expenditure.
24. **Adani Group's Vizhinjam Port in Kerala** has received approval from the government to operate as India's inaugural transshipment port. This designation is significant as it allows cargo to be transferred from large vessels to smaller ones, contributing to India's goal of becoming a manufacturing hub. Presently, a substantial portion of India's transshipment cargo is handled by ports abroad, such as those in Colombo and Singapore.
25. **The International Cricket Council (ICC)** has announced the appointment of Indian cricket legend **Yuvraj Singh** as an ambassador for the upcoming **ICC Men's T20 World Cup 2024.** The announcement comes with just 36 days remaining until the highly anticipated global event for T20 cricket commences.
26. The International Cricket Council (ICC) has announced the appointment of Pakistan cricket legend **Sana Mir** as the ambassador for the upcoming **ICC Women's T20 World Cup Qualifier.** Mir, who represented Pakistan in 226 international games, with 137 of them as captain, will bring her invaluable experience to the event.
27. **External Affairs Minister S. Jaishankar** received a copy of the book **'India's Nuclear Titans,'** edited by **Soumya Awasthi and Shrabana Barua.** The book traces the evolution of India into a nuclear state while highlighting the pivotal roles played by renowned figures like Homi Bhabha, Vikram Sarabhai, Abdul

- Kalam, and K. Subrahmanyam, among others.
28. **The World Day for Safety and Health at Work is an annual international campaign observed on April 28th** to promote safe and healthy working conditions for all workers. This year, World Veterinary Day will be celebrated on Saturday, April 27, 2024. The theme for 2024 is “**Veterinarians are Essential Health Workers,**”.
 29. **World Veterinary Day 2024 Observed on 27th April.** The World Veterinary Day (WVD) is an annual global celebration that honours the invaluable contributions of veterinarians to society.
 30. The world of Yakshagana, a traditional theatre form of Karnataka, has lost a towering figure. **Subrahmanya Dhareshwar**, a senior and well-known Yakshagana ‘bhagavatha’ (background singer), passed away in Bengaluru. He was 66 years old.
 31. In a strategic move within the government’s leadership hierarchy, Pakistan Prime Minister **Shehbaz Sharif** has appointed Foreign Minister Ishaq Dar as the country’s Deputy Prime Minister with immediate effect, as reported by Samaa TV.
 32. **The Iranian Islamic Revolutionary Guard Corps (IRGC)** has introduced a new kamikaze drone resembling Russia’s Lancet drone. This drone, yet to be named publicly, is designed for targeted attacks, akin to those witnessed in the Ukraine conflict.
 33. Iraq’s parliament recently passed a stringent law criminalizing **same-sex relationships**, imposing a maximum **15-year prison sentence**. The legislation, titled the Law on Combating Prostitution and Homosexuality, reflects a concerning trend of increased scrutiny and persecution of LGBT individuals in Iraq.
 34. **China’s Growing Share in India’s Industrial Goods Imports: Implications and Recommendations.** The increasing reliance of India on Chinese industrial goods presents significant economic and security concerns, with China’s share in New Delhi’s imports rising from 21% to 30% over the last 15 years. This situation demands a strategic reassessment of import strategies to foster diversified and resilient supply chains.
 35. **The Ministry of Housing & Urban Affairs (MoHUA)** has welcomed a new addition to its leadership team. **Sunil Kumar Yadav**, an officer from the Indian Revenue Service (IRS), has been appointed as the Director of the Ministry of Housing & Urban Affairs.
 36. The Reserve Bank of India (RBI) has issued comprehensive guidelines outlining the voluntary transition path for **Small Finance Banks (SFBs)** seeking to become Universal Banks. These guidelines set specific eligibility criteria and procedural requirements for such a transition, aiming to ensure financial stability

and operational effectiveness in the banking sector.

37. **Hitachi Payment Services** has unveiled new upgradable ATMs in India, allowing banks to adapt their machines into **Cash Recycling Machines (CRMs)** as per evolving needs. Manufactured under the 'Make in India' initiative, these ATMs offer flexibility and efficiency to banks, potentially revolutionizing the Indian ATM industry.
38. **The Indian Renewable Energy Development Agency (IREDA)**, a public sector enterprise, has been granted the coveted '**Navratna**' status by the government, according to a recent filing with the stock exchanges. This prestigious designation takes the total number of Navratna PSEs (Public Sector Enterprises) in India to 17.
39. Gina Justus, an English High School teacher at the **Sharjah Girls Branch in the United Arab Emirates (UAE)**, has been named the regional **winner for the Middle East and North Africa (MENA) region at the prestigious 2024 Cambridge Dedicated Teacher Awards**. This achievement celebrates her outstanding mentorship and dedication to charity work.
40. The Indian athletes continued their impressive medal-winning spree at the **21st U-20 Asian Athletics Championship 2024**, with **Harshit Kumar** clinching a gold medal in the highly competitive Hammer throw event. His outstanding throw of 66.7

meters secured India's latest gold at the prestigious event.

41. A Book Titled "**The Winner's Mindset**," Authored by **Shane Watson**. In his book, "The Winner's Mindset," Watson shares the insights and strategies that enabled him to conquer his fears and reach new heights in his cricketing career. While the book is not an autobiography in the traditional sense, it serves as a powerful self-help guide, offering readers a glimpse into the mindset that propels individuals to success.
42. **International Jazz Day, celebrated annually on April 30th**, is a global event that celebrates the power of jazz to bring people together and promote peace, unity, and intercultural dialogue. This year marks a significant milestone as the city of Tangier, Morocco becomes the first African host city for the global celebration.
43. **International Dance Day, celebrated annually on April 29th**, stands as a global tribute to the art of dance. Conceived by the Dance Committee of the International Theatre Institute (ITI), an essential partner of UNESCO in the realm of performing arts, this day commemorates the birth of Jean-Georges Noverre (1727–1810), revered as the progenitor of modern ballet.
44. **Humza Yousaf**, Scotland's first Muslim First Minister and leader of the Scottish National Party (SNP), has announced his resignation amid political turmoil. The decision follows the collapse of the SNP's coalition

with the Scottish Greens, triggering opposition no-confidence motions. Yousaf cited a refusal to compromise his values and principles for political power, amidst challenges including a funding scandal and the departure of former leader Nicola Sturgeon.

45. **Sri Lanka**, amidst a financial crisis stemming from a severe shortage of dollars, has taken a significant step by **partially lifting import restrictions**. This move aims to rejuvenate the economy, which has been struggling since March 2020.
46. The government of Tamil Nadu has launched a three-day survey of the **Nilgiri Tahr**, the state's iconic animal. This initiative aims to better understand and conserve this endangered species that faces numerous challenges, including habitat loss and poaching.
47. **Sarvadanand Barnwal**, an Indian Statistical Service (ISS) officer of the 2010 batch, has been appointed as Director in the Department of Land Resources. The appointment was made on Friday, April 26, 2024, through an order issued by the Department of Personnel & Training (DoPT).
48. In a significant development, the **Indian Vaccine Manufacturers Association (IVMA)** has announced the appointment of **Krishna Ella**, co-founder and executive chairman of Bharat Biotech, as its new president for the next two years, effective April 2024. Ella will take over the presidency from Adar C. Poonawala,

who held the position from 2019 to March 2024.

49. **Sana**, the AI-powered news anchor developed by the India Today Group, has achieved remarkable success at the prestigious **International News Media Association (INMA)** Global Media Awards held in London. This groundbreaking AI innovation has captured two coveted awards, solidifying its position as a trailblazer in the field of AI-driven journalism.
50. **Alok Shukla**, a renowned environmental activist and convenor of **Chhattisgarh Bachao Andolan**, has been selected for the prestigious 2024 Goldman Environmental Prize. Also known as the "**Green Nobel Prize**," this annual award honours grassroots environmental champions worldwide for their outstanding contributions to environmental protection.
51. Noted Hindi film superstars **Hema Malini and Saira Banu**, along with other prominent personalities from the fields of art and culture, will be honoured with the prestigious **Pandit Lacchu Maharaj Award**. The award ceremony will take place on 31 August 2024 in Lucknow, Uttar Pradesh.
52. **Manipal Academy of Higher Education (MAHE)** honored **K.V. Kamath**, Chairman of National Bank for Financing Infrastructure and Development and Chairman of Jio Financial Services Ltd., with an honorary doctorate at a special convocation on April 29, 2024. The ceremony celebrated Kamath's

- exceptional leadership in banking, finance, and sustainable development, recognizing his significant contributions to India's financial sector and global impact.
- 53.** In a collaborative effort between the **Systematic Voters' Education and Electoral Participation Cell (SVEEP)** of Kamrup Election District and the Indian Institute of Technology Guwahati, a groundbreaking 3D-printed dummy ballot unit has been unveiled. The initiative aims to enhance voter awareness and engagement, particularly among new voters and senior citizens, by providing a practical experience of the voting process.
- 54.** **The Indian Air Force (IAF) and Indian Navy** have bolstered their combat capabilities with the induction of the Rampage long-range supersonic air-to-ground missile, previously utilized by the Israeli Air Force in operations against Iranian targets. The missile, known as the **High-Speed Low Drag-Mark 2** within the Indian Air Force, offers a striking range of up to 250 kilometers.
- 55.** **The Chennai Super Kings (CSK)** secured a resounding 78-run victory over the Sunrisers Hyderabad (SRH) on Sunday, potentially shaping the trajectory of both teams' 2024 Indian Premier League (IPL) campaigns. This emphatic win significantly boosted CSK's net run rate, propelling them to the third position in the league standings. Conversely, SRH suffered their second consecutive defeat, slipping to the fourth spot.
- 56.** **Ayushman Bharat Diwas** is celebrated annually on **April 30** to raise awareness about the Ayushman Bharat Yojana and its goals. This year, it falls on Tuesday, April 30, 2024. The day was established by the government to highlight the scheme's objective of providing better access to affordable and quality healthcare services, especially for the underprivileged.
- 57.** A report by **the Global Trade Research Initiative (GTRI)** highlights India's escalating dependence on Chinese imports, with the import bill surging to over \$101 billion in 2023-24 from around \$70 billion in 2018-19. Over the past fifteen years, China's share of India's industrial goods imports has risen significantly, reaching 30%, while imports from China have outpaced India's total imports by 2.3 times.
- 58.** Zimbabwe has launched a new currency called the **ZiG (short for Zimbabwe Gold)** in an attempt to address the country's long-running currency crisis. The ZiG, backed by Zimbabwe's gold reserves, was introduced electronically in early April and has now been released in banknote and coin form.
- 59.** **Paleontologists** from **Argentina** have revealed the unearthing of a novel medium-sized herbivorous dinosaur, *Chakisaurus nekul*, which thrived approximately 90 million years ago during the Late Cretaceous period in present-day Patagonia. The finding, detailed in the journal *Cretaceous Research*,

sheds light on a remarkable creature known for its speed and unique tail anatomy.

60. **The Uttarakhand government** has suspended the manufacturing licenses of **14 products from Patanjali Ayurved, founded by Baba Ramdev**, citing misleading advertisements about their efficacy. This move comes amid ongoing scrutiny and legal proceedings against Ramdev for non-compliance with directives to cease misleading advertising.
61. In a strategic move, Cred has launched an innovative UPI-based '**Scan and Pay**' service, marking its entry into the offline payments sphere, challenging incumbents like PhonePe, Google Pay, and Paytm. This service allows users to make payments directly from their bank accounts using any QR code, extending convenience to large format stores such as supermarkets, fast-food joints, beauty salons, and fashion boutiques.
62. **The Reserve Bank of India (RBI)** has revoked the license of **Acemoney (India) Limited, a Delhi-based non-banking financial company (NBFC)**, citing irregular lending practices. This action stems from the company's violation of RBI guidelines regarding excessive interest charges and inadequate protection of customer information. Specifically, the RBI noted discrepancies in Acemoney's management of risks and code of
63. conduct in its digital lending operations through third-party apps. India has adjusted its windfall tax on petroleum crude, reducing it to **8,400 Indian rupees (\$100.66) per metric ton from 9,600 rupees, effective May 1**. This decision comes after a recent increase in the tax from 6,800 rupees to 9,600 rupees per metric ton on April 16.
64. **Justice (retired) Dinesh Kumar** took charge as the **Presiding Officer of the Securities Appellate Tribunal (SAT) on 29 April 2024**. The government of India appointed Justice Dinesh Kumar for a four-year term. Before taking over as the presiding officer of SAT, Justice Dinesh Kumar was the chief justice of the Karnataka High Court. He retired from the post in February 2024.
65. **India's Bharat 6G Alliance is set to sign a cooperation agreement with Europe's Industry Alliance 6G**, following a similar agreement with the US. This partnership aims to foster collaboration in developing 6G technology.
66. **The 16th edition of the Tata Consultancy Services World 10K** Bengaluru witnessed Kenyan runners Peter Mwaniki (28:15) and Lilian Kasait (30:56) emerging victorious in the international elite men's and women's categories, respectively.
67. In a triumphant display of dominance, **Paris Saint-Germain secured their record 12th Ligue-1 title in the 2023-24 season**. The club's relentless pursuit of excellence saw them claim victory

- for the third consecutive year, further solidifying their stature as a powerhouse in French football. Under the astute leadership of coach Luis Enrique, PSG showcased their prowess with a commanding performance throughout the season.
- 68.** In a remarkable achievement, **Emeritus**, the Indian edtech startup, has secured the coveted top spot in TIME Magazine's "**World's Top EdTech Companies of 2024**" ranking. Founded in 2015 by Ashwin Damera and Chaitanya Kalipatnapu, Emeritus offers courses from prestigious global universities, including the University of Cambridge, Harvard Business School, and MIT Sloan, among others.
- 69.** **International Labour Day, also known as May Day or Workers' Day, is celebrated on Wednesday, May 1st, 2024.** This annual observance honours the contributions and achievements of workers worldwide and promotes their rights and opportunities. Every year, the theme is announced by international labour organisations like the International Labour Organization (ILO). This year, the focus is on ensuring safety and health at work in a changing climate.
- 70.** **Vinay Vir**, a renowned journalist, publisher, and editor of the **Daily Hindi Milap**, passed away on Saturday, April 27th, 2024, at the age of 72. He was a champion for the Hindi language in South India and a respected figure in the journalism community.
- 71.** **The Government of India** has signed an agreement with the **Government of Bangladesh** to renew the Memorandum of Understanding (MoU) for training **1500 Bangladeshi officers from 2025 to 2030**. The agreement was signed between the Department of Administrative Reforms and Public Grievances (DARPG), Government of India, and the Bangladeshi Ministry of Public Administration.
- 72.** **India to Host 46th Antarctic Treaty Consultative Meeting in Kochi.** India reaffirms its commitment to safeguarding Antarctica's delicate ecosystem and advancing scientific exploration in the region. The Ministry of Earth Sciences (MoES), Government of India, in collaboration with the National Centre for Polar and Ocean Research (NCPOR), is set to host the 46th Antarctic Treaty Consultative Meeting (ATCM 46) and the 26th Meeting of the Committee for Environmental Protection (CEP 26) from May 20 to 30, 2024, in Kochi, Kerala.
- 73.** **The Ministry of Corporate Affairs (MCA)** has granted its approval for the appointment of **Hitesh Kumar Sethia as the Managing Director and Chief Executive Officer of Jio Financial Services** for a three-year period, effective from November 15, 2023.
- 74.** **Kathmandu Tops The List of Cities With 'unhealthy air' in the World.** The Ministry of Health and Population of Nepal has urged

residents to wear masks due to the alarming increase in air pollution levels in the Kathmandu valley. According to IQAir, an organization that measures real-time pollution in 101 cities worldwide, Kathmandu has been ranked as the most polluted city globally.

75. China is set to launch the **Chang'e-6 lunar probe** on a round trip to the Moon, marking a significant advancement in their space exploration. The mission aims to gather soil and rock samples from the far side of the Moon, providing crucial insights into its early evolution and the inner solar system.
76. **Worldline ePayments India** has announced its receipt of approval from the Reserve Bank of India (RBI) to operate as a payment aggregator. This approval underscores the company's dedication to the Indian market and emphasizes its commitment to compliance within a well-regulated payments landscape.
77. In April 2024, **Unified Payment Interface (UPI)** transactions witnessed a marginal dip of **1% in volume and 0.7%** in value compared to March. Despite this, year-on-year growth remains robust, with a 50% increase in volume and 40% in value. The dip in April is attributed to the typically higher transaction volumes in March.
78. In April 2024, India witnessed a historic milestone in its **Goods and Services Tax (GST)** revenue collection, reaching an unprecedented **Rs 2.10 lakh crore**.

This marked a substantial 12.4% increase from the previous year's collections. The surge was primarily driven by a robust 13.4% growth in domestic transactions and an 8.3% rise in imports.

79. In March, the growth of India's core sectors slowed to **5.2% from February's 7.1%**, primarily due to the statistical effect of a high base. However, sequentially, there was a notable increase of 9.9%, marking the highest growth in a year.
80. **Indian Oil Corporation (IOC)** has announced a significant investment of **Rs 5,215 crore to develop 1 gigawatt (GW)** of renewable energy capacity in India. This strategic move aligns with IOC's broader diversification strategy beyond traditional oil and gas ventures.
81. The Indian Army and the **Punit Balan Group** joined hands to inaugurate the nation's first Constitution Park in Pune. The ceremony, led by **Lt. Gen.
