- 1. The Hurun India Rich List 2024** has unveiled a significant shift in the landscape of wealth distribution across Asia, with Mumbai emerging as the new **“billionaire capital of Asia”**. This development marks a pivotal moment in the economic narrative of India and Asia at large, showcasing the growing financial prowess of India’s commercial hub.
- 2. Infosys** has expanded its partnership with **NVIDIA to develop generative AI solutions tailored for telecom operators**. Utilizing NVIDIA’s NIM inference microservices, NeMo Retriever models, NeMo Guardrails, and Riva. Infosys aims to enhance telecommunication operations and customer service. Early results show significant improvements in latency and accuracy.
- 3. The Union Minister of Women and Child Development, Annapurna Devi, launched the new SHe-Box portal**, a centralized platform aimed at making workplaces safer for women by addressing complaints of sexual harassment. The launch event, held in New Delhi, also included the introduction of a revamped ministry website.
- 4. The US-India Strategic Partnership Forum** announced the third edition of the **India-US Defense Acceleration Ecosystem (INDUS-X)** Summit at Stanford University on Sept 9-10, 2024. The summit will focus on leveraging private investment to advance defense innovation and will feature top policymakers, panel discussions, and a tech expo.
- 5. Bangladesh** has emerged as the new champion of the **SAFF (South Asian Football Federation) U-20 Championship football tournament**. This victory marks a significant milestone in Bangladesh’s football history, as it is the first time the nation has claimed this prestigious title. The tournament, which showcased the talent of young South Asian footballers, concluded with a thrilling final match that saw Bangladesh defeat the host nation, Nepal.
- 6. The International Day of the Victims of Enforced Disappearances, observed annually on August 30th**, sheds light on a horrific practice that continues to plague societies worldwide. Enforced disappearances, a tool of oppression and terror, involve the arrest or abduction of individuals by state actors, followed by a refusal to acknowledge their whereabouts or fate. This article delves into the history, impact, and global prevalence of this human rights violation.
- 7. The Indian Army** has launched the first phase of **Project NAMAN**, aimed at providing dedicated support and

services to Defence pensioners, veterans, and their families. The project, inaugurated by Chief of the Army Staff General Upendra Dwivedi and the President of the Army Wives Welfare Association, Mrs. Sunita Dwivedi, is a significant step toward enhancing the care and support for the Defence community.

8. Finance Minister Nirmala Sitharaman granted **'Navratna' status to four Central Public Sector Enterprises (CPSEs)**: NHPC, Solar Energy Corporation of India (SECI), Railtel Corporation of India (RCIL), and Satluj Jal Vidyut Nigam (SJVN). This brings the total number of Navratna CPSEs in India to 25. The Navratna status provides these entities with increased financial and operational autonomy.
9. Prime Minister Narendra Modi will flag off three new **Vande Bharat trains around 12:30 pm on August 31**. "These new Vande Bharat trains shall provide the people of the region the world-class means to travel with speed and comfort and will cater to three states – Uttar Pradesh, Tamil Nadu, and Karnataka," the government said in a press release.
10. **INS Tabar**, a frontline frigate of the Indian Navy, visited Malaga, Spain, on **25 August 2024**, for a two-day engagement. Upon departure on 27 August, it participated in a Maritime Partnership Exercise (MPX) with the Spanish Navy Ship Atalaya in the Mediterranean Sea. This exercise is a significant milestone in the growing maritime cooperation between India and Spain, reflecting the strengthening of bilateral relations in the maritime domain.
11. **On the occasion of National Sports Day**, Bihar took a significant leap

forward in its commitment to sports development. **Chief Minister Nitish Kumar** inaugurated a trio of state-of-the-art facilities in Rajgir, marking a new chapter in the state's sporting history. These facilities, comprising a sports academy, a sports complex, and a sports university, are set to revolutionize the athletic landscape of Bihar and potentially influence sports development across India.

12. **Dr. T.V. Somanathan, a senior IAS officer of the 1987 Tamil Nadu cadre**, has assumed the role of Cabinet Secretary for the Government of India, succeeding Rajiv Gauba after his superannuation. Dr. Somanathan brings extensive experience from both central and state government positions, as well as international roles, notably at the World Bank. His academic credentials include a Ph.D. in Economics, and he is a qualified Chartered Accountant, Cost Accountant, and Company Secretary.
13. **The Reserve Bank of India (RBI)** has levied penalties on two financial entities for regulatory non-compliance. **UCO Bank has been fined Rs 2.68 crore** for violating provisions related to current account openings, deposit interest rates, and fraud classification. Meanwhile, Cent Bank Home Finance Ltd faces a Rs 2.1 lakh penalty for failing to adhere to Know Your Customer (KYC) regulations. The RBI clarified that these penalties are imposed for regulatory compliance issues and do not impact the validity of transactions or agreements between the banks and their customers.
14. **The Federation of Indian Chambers of Commerce and Industry (FICCI)** recently organized its prestigious Young Leaders Awards in New Delhi,

bringing together a diverse array of talented individuals from various fields. The ceremony was graced by two outstanding personalities who received the coveted FICCI Young Leaders Youth Icon award:

- Ayushmann Khurrana: Bollywood superstar and versatile actor
- Neeraj Chopra: Olympic gold medalist in javelin throw

15. In a significant achievement for Indian tourism, **Kerala Tourism** has once again put India on the global tourism map by winning the prestigious Pacific Asia Travel Association (PATA) Gold Award 2024. This accolade recognizes the state's innovative online contest, 'Holiday Heist', in the Digital Marketing Campaign category, further cementing Kerala's position as a leader in creative tourism promotion.

16. In a groundbreaking initiative to inspire and educate the youth about the rich history and heroic deeds of the **Indian Air Force (IAF)**, **Air Chief Marshal V R Chaudhari has launched the first comic book in a series dedicated to IAF heroes.** This innovative approach to storytelling marks a significant step in the IAF's efforts to connect with younger generations and foster a sense of pride and duty towards the nation.

17. Mona Agarwal made history at the **2024 Paralympics by securing a bronze medal in the women's 10m air rifle standing SH1 event on August 30.** Her journey to the podium was not just about athletic excellence but also a testament to her resilience as a mother of two. Challenges, she faced leading up to the competition, particularly the struggle of balancing

her responsibilities as a mother with her ambitions as an athlete.

18. The International Day for People of African Descent Observed on 31st August to marks a significant milestone in the global recognition of the contributions and challenges faced by individuals of African descent worldwide. As we commemorate this day, we also approach the conclusion of the International Decade for People of African Descent, an initiative launched by the United Nations General Assembly to safeguard the human rights of people of African descent, particularly in the Americas

19. India Post Payments Bank (IPPB), a key player in driving financial inclusion across India, proudly marked its 7th Foundation Day on September 2, 2024. Since its nationwide launch in 2018 by Prime Minister Shri Narendra Modi, the IPPB has been instrumental in transforming India's financial landscape by providing accessible, affordable, and trusted digital banking services to underserved and unbanked families at their doorstep.

20. Prime Minister Shri Narendra Modi addressed the Economic Times World Leaders Forum in New Delhi, where he highlighted India's economic growth, governance, and global ambitions. PM Modi emphasized that India's economy has grown by 90% over the last decade, significantly outpacing the global economy's 35% growth. He attributed this success to sustained reforms and assured that the government remains committed to continued growth.

21. Prime Minister Narendra Modi unveiled a commemorative postage stamp celebrating 75 years of the

Supreme Court of India during the inaugural session of the District Judges Conference at Bharat Mandapam in New Delhi. The event was attended by Supreme Court Chief Justice Dr. D.Y. Chandrachud, Minister of Law & Justice Arjun Ram Meghwal, and other dignitaries.

22. The **7th Rashtriya Poshan Maah** was launched today at Mahatma Mandir, Gandhinagar, Gujarat, marking a significant step towards enhancing **nutrition awareness and well-being across the nation**. The event featured prominent figures such as Union Minister Smt. Annpurna Devi, Chief Minister of Gujarat Shri Bhupendrabhai Patel, and Gujarat's Minister of Women and Child Development Smt. Bhanuben Babariya, alongside senior officials from both the Government of India and the State Government of Gujarat.
23. The **University of Manipur**, in collaboration with the **National Human Rights Commission (NHRC)**, successfully hosted a two-day **'Training Programme on Human Rights in India'** on 30th August 2024 at the Court Hall, Manipur University. The event saw participation from over 100 legal experts, academicians, human rights defenders, and students.
24. In a historic step towards developing sports infrastructure in Bihar, **Hockey India** announced that the upcoming **Hockey Women's Asian Champions Trophy 2024 will be held in Rajgir from November 11 to 20**. The tournament will take place at the newly constructed Rajgir Hockey Stadium, where India will defend their title against teams from China, Malaysia, Japan, Thailand, and Korea.
25. **Air Marshal Ashutosh Dixit Takes Over As AOC-In-C, Central Air Command**. Air Marshal Ashutosh Dixit, Ati Vishisht Seva Medal, Vayu Sena Medal, Vishisht Seva Medal, assumed the appointment of Air Officer Commanding-in-Chief of Central Air Command on September 1. Air Marshal Dixit was commissioned into the fighter stream of IAF on December 6, 1986. The Air Officer is an experimental test pilot and a qualified flying instructor with more than 3300 hours of flying experience on a variety of aircraft in the IAF inventory.
26. **V. Satish Kumar**, the director (marketing) of **Indian Oil Corporation Ltd. (IOCL)**, has assumed additional charge as the chairman, following the completion of Shrikant Madhav Vaidya's tenure. Kumar, who has been with IOCL for 35 years, has held key positions across various regions and led significant initiatives in the company's marketing division.
27. In **August 2024**, India's GST collections reached **₹1.75 lakh crore**, marking a 10% year-on-year growth compared to ₹1.59 lakh crore in August 2023. This increase reflects robust domestic consumption and higher imports. The central government collected ₹30,862 crore, while states collected ₹38,411 crore before adjustments. IGST on imports and inter-state sales amounted to ₹93,621 crore.
28. **President Emmanuel Macron Awarded Olympic Order in Gold for Paris 2024 Success**. In a ceremony that underscored his exceptional contributions to the Olympic movement, President Emmanuel Macron of France was awarded the Olympic Order in gold. This prestigious distinction was bestowed upon him by

the International Olympic Committee (IOC) in recognition of his unwavering support for the Olympic Games Paris 2024 and his commitment to the Olympic ideals championed by Pierre de Coubertin. Macron's involvement was pivotal in making the Paris 2024 edition a resounding success, symbolizing global unity and the enduring power of sport.

29. In a momentous recognition of his contributions to the world of animation and storytelling, **Hayao Miyazaki**, the renowned Japanese film director and co-founder of Studio Ghibli, has been awarded the esteemed **Ramon Magsaysay Award for 2024**. This honor, often referred to as **"Asia's Nobel Prize,"** underscores Miyazaki's profound impact on both the art of animation and global cultural discourse.
30. **Rubina Francis** etched her name in **Paralympic history on August 31**, with a bronze medal in Paris. She rose on the occasion and clinched a bronze in the women's 10m air pistol SH1 event. Para-athletes never have an easy journey, as they have to fight against all odds and show grit and resilience to reach the top, which was also the case with Rubina.
31. **Preethi Pal Becomes First Indian Woman To Win Two Paralympic Medals In Athletics.** At Paris Paralympics 2024, Indian Para Athlete Preethi Pal secured yet another medal for India, clinching a Bronze medal in the Women's 200 meters – T35 Final. She won the medal with a personal best timing of 30.01 seconds. With this win, she became the first track and field Indian Woman Para Athlete to win two medals at the Paralympics.
32. **India's Nishad Kumar** secured a **silver medal** in the men's T47 high jump final at the Paris Paralympics on September 2. Kumar, who previously claimed silver in Tokyo, recorded his season-best jump of 2.04 meters to finish in second place. Townsend-Roberts of the United States claimed the gold medal with a season-best jump of 2.08 meters, pulling ahead of India's Nishad Kumar. Russia's Georgii Margiev took home the bronze.
33. **National Nutrition Week (NNW)** is an annual observance in India, taking place from September 1 to 7. This week-long event is dedicated to raising awareness about the critical role of nutrition in our lives and promoting healthy eating habits among people of all ages.
34. **World Coconut Day was established in 2009** by the **Asian and Pacific Coconut Community (APCC)**, an intergovernmental organization under the United Nations Economic and Social Commission for Asia and the Pacific. The APCC, representing 19 coconut-producing countries in the Asia-Pacific region, chose September 2 to commemorate the organization's founding in 1969.
35. In a significant event marking the evolution of India's judiciary, **President Droupadi Murmu** unveiled the **new flag and insignia** of the Supreme Court of India during the two-day National Conference of District Judiciary held in New Delhi. The ceremony, attended by members of the judiciary from across the nation, symbolized the rich cultural and legal heritage of India, encapsulated in the newly designed symbols of the highest court.

36. In a historic move that underscores India's commitment to becoming a **global hub for semiconductor manufacturing**, the Union Cabinet, chaired by Prime Minister Narendra Modi, approved the proposal of Kaynes Semicon Pvt Ltd to establish a semiconductor manufacturing unit in Sanand, Gujarat. The meeting, held in New Delhi on 2 September 2024, marks a significant milestone in India's Semiconductor Mission, which was launched in 2022 to boost the country's semiconductor capabilities.
37. **The Uttar Pradesh** government is set to make a significant investment of approximately **Rs 33,500 crore (around \$4 billion) to spur growth in the Information Technology (IT) and IT-enabled Services (ITeS)** sectors over the next five years. The plan aims for a tenfold increase in these sectors by developing technology hubs across five major cities: Noida, Lucknow, Kanpur, Varanasi, and Prayagraj (Allahabad).
38. **Dutch multinational conglomerate Philips** has appointed **Bharath Sesha as the Managing Director for India, effective September 1**. Sesha will lead the company's growth strategy in India, focusing on enhancing customer satisfaction and driving operational excellence, particularly in the healthcare sector. He succeeds Daniel Mazon, who has transitioned to a global role at Philips' headquarters in the Netherlands.
39. **The World Bank** has revised its growth forecast for the Indian economy, increasing it to **7% for the fiscal year 2024-25, up from the earlier estimate of 6.6%**. This adjustment comes despite a slowdown to 6.7% in the April-June quarter, attributed to reduced government spending during national elections.
40. **Bisleri International Pvt. Ltd.** has partnered with the Government of Goa to improve waste management in Mormugao, Vasco. This collaboration was solidified during the Green Goa Summit 2024, where a Letter of Intent (LOI) was exchanged between Bisleri and the Goa State Pollution Control Board, with the presence of Chief Minister Dr. Pramod Sawant. The partnership aims to enhance plastic waste management under Bisleri's CSR initiative, **'Bottles for Change,'** focusing on sustainable development and environmental stewardship.
41. **Reliance Industries Limited (RIL)** has made history as the first Indian company to exceed ₹10 lakh crore in annual revenue. This milestone was revealed during **RIL's Annual General Meeting (AGM)** by Chairman Mukesh Ambani. For the financial year 2023-24, Reliance achieved a record consolidated turnover of ₹10,00,122 crore (USD 119.9 billion), with a net profit of ₹79,020 crore (USD 9.5 billion).
42. **Google DeepMind's India** unit is spearheading an ambitious **AI project named Morni (Multimodal Representation for India)**, aiming to encompass 125 Indic languages and dialects. Speaking at the Global Fintech Fest, Manish Gupta, Director of Google DeepMind India, highlighted that among these languages, 73 had no existing digital corpus. Despite Hindi being spoken by nearly 10% of the global population, its online text representation is just 0.1%.
43. The prestigious **Lord's Cricket Ground in London** is set to make history by hosting the final of the **ICC World Test**

Championship (WTC) from June 11 to June 15, 2025. This event marks the first time that the iconic venue, often referred to as the “**Home of Cricket,**” will host the climax of cricket’s most revered format.

44. Guwahati-based NorthEast United Football Club etched their names in Indian football history by clinching their maiden Durand Cup title. In a thrilling final that went to a penalty shootout, they defeated the defending champions, Mohun Bagan Super Giant (MBSG), 4-3. The match took place at the iconic Vivekananda Yuba Bharati Krirangan in Kolkata on August 31, 2024.

45. Indian duo of Sheetal Devi and Rakesh Kumar claimed the bronze medal in the mixed team compound archery competition at the Paralympics 2024 on September 2nd. Their victory was secured with a nail-biting 156-155 win over Italy’s Eleonora Sarti and Matteo Bonacina, marking only the second time that India has won a medal in archery at the Paralympics.

46. Indian para-badminton star Suhas Lalinakere Yathiraj added yet another accolade to his remarkable career by winning the silver medal in the men’s singles SL4 category at the **Paris 2024 Paralympics**. The match took place at the historic Stade Pierre de Coubertin, where Suhas faced off against world champion Lucas Mazur. Despite a hard-fought battle, Suhas had to settle for silver, but his exceptional performance solidified his position as one of India’s top para-athletes.

47. In a remarkable display of skill and perseverance, Indian para-badminton players **Thulasimathi Murugesan and Manisha Ramadass** clinched silver and bronze medals, respectively, in the

women’s singles SU5 class at the **Paris 2024 Paralympics**. Their outstanding performances not only showcased their exceptional talent but also marked a historic moment for Indian badminton.

48. Union Cabinet Approves Seven Schemes to Boost Farmers’ Incomes and Improve Agriculture. In a significant move to enhance the lives of farmers and increase their incomes, the Union Cabinet, chaired by Prime Minister Shri Narendra Modi, has given its approval to seven comprehensive schemes. These initiatives, with a total outlay of Rs 14,235.30 Crore, aim to revolutionize various aspects of agriculture in India.

49. The **Madhya Pradesh government**, under the leadership of **Chief Minister Mohan Yadav**, has approved a groundbreaking scheme named ‘**Brindavan Gram**’. This initiative, formally announced on Janmashtami (August 26), aims to transform selected gram panchayats into model villages, focusing on cow protection and rural development.

50. In a landmark event for both **Indian and UAE** educational landscapes, **Sheikh Khaled bin Mohamed bin Zayed Al Nahyan, the Crown Prince of Abu Dhabi**, has officially inaugurated the Indian Institute of Technology (IIT) Delhi Abu Dhabi campus. This momentous occasion marks the first time the prestigious IIT brand has established a full-fledged campus outside India, signifying a major leap in international academic collaboration.

51. French cosmetics giant L’Oreal Paris has made a significant announcement, revealing that it has signed **Alia Bhatt**, one of Bollywood’s most prominent actresses, as its newest global brand

ambassador. This partnership marks a major milestone for both the brand and the actress, signaling L’Oreal’s continued focus on diversity and global representation.

52. Paralympics 2024: Sharad Kumar and Mariyappan Thangavelu Secured Silver and Bronze medals.

In a remarkable display of skill and determination, Sharad Kumar and Mariyappan Thangavelu secured silver and bronze medals respectively in the men’s high jump T63 event.

- Sharad Kumar cleared a height of 1.88m, earning him the silver medal.
- Mariyappan Thangavelu achieved a best effort of 1.85m, securing the bronze.

53. Deepthi Jeevanji’s Bronze Triumph at the 2024 Paris Paralympics.

In a remarkable display of athleticism and determination, Deepthi Jeevanji, the 20-year-old world champion sprinter from India, has secured a bronze medal in the women’s 400m T20 event at the 2024 Paris Paralympics. This achievement marks a significant milestone in Jeevanji’s career, coming in her debut Games appearance.

54. In a remarkable display of skill, determination, and athletic prowess, Sumit Antil etched his name in the annals of Indian sports history at the Paris 2024 Paralympics.

The 26-year-old para-athlete not only claimed the **gold medal in the men’s javelin throw F64** class but also became the first Indian male para-athlete to successfully defend his Paralympic title.

55. On September 3, 2024, Prime Minister Narendra Modi embarked on a significant diplomatic journey by arriving in Bandar Seri Begawan, the

capital of Brunei. This visit marks a historic milestone as it is the first time an Indian Prime Minister has visited Brunei since the establishment of diplomatic ties between the two nations on May 10, 1984. The visit is part of a broader two-nation tour that includes Singapore, spanning from September 3 to 5, 2024.

56. India is setting ambitious goals to significantly increase its presence in the global alcoholic beverage market, targeting exports worth US\$ 952.9 million (Rs. 8,000 crore) in the coming years.

As part of the ‘**Make in India**’ initiative, the government, supported by the Agricultural & Processed Food Products Export Development Authority (APEDA), seeks to elevate India from its current 40th position in global alcoholic beverage exports. The aim is to achieve US\$ 1 billion in export revenue.

57. The Board of Control for Cricket in India (BCCI) made a significant announcement on Tuesday, reshaping the landscape of Indian cricket’s selection process.

Former India wicketkeeper Ajay Ratra has been appointed as a selector for the men’s cricket team, marking a new era in the national team’s selection committee.

58. During the 11th day of the Ultimate Table Tennis (UTT) season five at the Jawaharlal Nehru Indoor Stadium, a significant announcement echoed through the table tennis community.

Sharath Kamal, India’s ace paddler, was named the first Indian ambassador of the International Table Tennis Federation (ITTF) Foundation.

59. India and Singapore have signed multiple agreements aimed at enhancing cooperation in semiconductors, healthcare, and

digital economies, elevating their ties to a comprehensive strategic partnership. Prime Minister Narendra Modi, during his visit to Singapore, emphasized the importance of collaboration for regional peace, stability, and prosperity, while describing Singapore as an “**inspiration**” for India’s development.

- 60. POP**, a fintech startup founded by former Flipkart employees, has introduced India’s first multi-brand co-branded credit card in partnership with **RuPay and Yes Bank**. This innovative card, known as the YEB BANK POP-CLUB RuPay credit card, integrates major brands like Zomato, Blinkit, Cult, Rapido, Cleartrip, and Pharmeasy to address key daily spending areas, including e-commerce, groceries, food and beverages, travel, and health and fitness.
- 61. The Vishvasya-Blockchain Technology Stack** was launched by the Ministry of Electronics and Information Technology (MeitY) to provide Blockchain-as-a-Service (BaaS) with a geographically distributed infrastructure. This initiative aims to support permissioned blockchain applications and promote transparent, secure, and trusted digital service delivery in India.
- 62. The Ministry of Women and Child Development** has been honored with the **National Award for e-Governance 2024 (Gold)** for its digital initiative, Poshan Tracker. This tool, part of Mission Poshan 2.0, enables real-time monitoring of children’s growth, focusing on those aged 0-6 years. Using WHO growth charts, the program tracks key anthropometric data, including height and weight,

helping Anganwadi Workers identify nutritional deviations early and intervene promptly. The program has achieved significant milestones, covering 8.9 crore children, with 8.57 crore measured in just one month.

- 63.** In a remarkable display of skill and precision, **Harvinder Singh** etched his name in the annals of Indian sports history by securing **India’s first-ever Paralympic gold medal in archery at the Paris 2024 Paralympics**. This achievement comes three years after his groundbreaking bronze medal at the Tokyo 2020 Paralympics, further solidifying his status as a trailblazer in Indian para-archery.
- 64. The Paris 2024 Paralympics** witnessed a remarkable performance by India’s **Sachin Sarjerao Khilari**, who secured a silver medal in the men’s shot put F46 event. This achievement not only adds to India’s growing medal tally but also highlights the nation’s emerging prowess in para-athletics.
- 65.** On Wednesday, September 4, 2024, the Paralympics in Paris witnessed an extraordinary display of skill and determination as Indian para-athletes dominated the men’s **F51 club** throw event. The competition showcased not only individual triumphs but also the rising prowess of India in Paralympic sports. **Dharambir**, the 35-year-old athlete from Sonapat, etched his name in Paralympic history with a spectacular performance. Complementing Dharambir’s gold was Pranav Soorma, who secured the silver medal.
